



RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK

In consideration of participating on the **ACRO-SPRING** (the "Activity") I represent that I understand the nature of this Activity and that I am qualified, in good health and in proper physical condition to participate in such Activity. In the event of injury, damage or loss due to Lessor's negligence, Lessee/Participant agrees and assumes the duty to mitigate all costs resulting from said injury, damage or loss.

By signing this contract, Lessee/Participant agrees no warranties either expressed or implied as to the condition or performance of any equipment and/or property leased or utilized by Lessee/Participant.
